The successful "earn as you learn" programming at Cookie Cart is based on a logic model constructed on principles of positive youth development, experiential learning with hands on engagements of knowledge application and habit building, with the most recent research on career pathways readiness. This method has created a 98 percent engagement rating from young adults within our program. Young people who participate gain or strengthen skills in five key outcome areas: connectedness to new communities, strengthened future goal orientation, improved interpersonal skills, enhanced critical thinking skills, and increased employment readiness skills. Over 86 percent of young adults achieve success in the entire curriculum model including financial literacy. Cookie Cart's programming typically serves 150-200 young
